Tony Smith made a motion to approve the Ethics Board Meeting Minutes of March 19, 2026. Vera Raglin provided the second. **The motion carried unanimously.**

2. Ethics Committee Officer Voting

Maya Osun made a motion to nominate Rodney Anderson as Chairperson of the Ethics Committee. Lee Walton provided the second. Mr. Anderson accepted the nomination. **The motion carried unanimously.**

Danita Jones said she felt the current officers had not served long enough in their positions due to the committee still being new and nominated Maya Olsen to continue serving as Chair.

Ethics Board Attorney Rory Starkey read Rule Three into the record, and said officers are elected annually by majority vote and serve a 12-month term. Mr. Starkey said the rule was that an officer must serve at least a 12-month term without interruption and stated re-election after serving a term would comply with the rule. Discussion included the possibility of amending the bylaws in the future to allow for longer officer terms, such as a 24-month term.

Danita Jones made a motion to nominate Vera Raglin as Vice-Chairperson of the Ethics Committee. Maya Osun provided the second. **The motion carried unanimously.**

Tony Smith made a motion to nominate Danita Jones as secretary of the Ethics Committee. Lee Walton provided the second. **The motion carried unanimously.**

Mr. Starkey explained the Secretary's responsibilities to include assisting with the proper filing and maintenance of board records and coordinating with the City Clerk's office when necessary. Mr. Starkey said the clerk's office maintains the majority of the official records while the Secretary assists with coordination and documentation matters involving the committee.

Members discussed agenda items for a future meeting to include training and meeting schedules.
